

The History of Prince Hall Scottish Rite

The first Scottish Rite organization among African-Americans was the African Grand Council of 1820 in Philadelphia, which was referred to as a Council of Princes of Jerusalem. This Council arose through West Indian migration, for Stephen Morin had propagated the Rite there. The organization of the King David Supreme Council grew out of conferring in Philadelphia (1850) of the 33rd Degree by Count DeSaint Laurent of the Supreme Council of Spain on David Leary, the first Black Inspector General of the Prince Hall Scottish Rite.

Scottish Rite Masonry came to Connecticut on August 20, 1892 and the New Haven Consistory No. 7 was chartered September 29, 1892 with Illustrious Robert L. Reed as its first Illustrious Commander-in-Chief. Brother Reed later served as the Sovereign Grand Commander of the United Supreme Council, Northern Jurisdiction from 1897-1898. Illustrious George W. Crawford, 33° of New Haven, served as Sovereign Grand Commander from 1949 through 1965. Our present Sovereign Grand Commander is Illustrious Brother Solomon Wallace, 33°, of Queens, New York.

Keith Kountz, News Anchor—Channel 8



Kountz first came to News Channel 8 in 1987 as a reporter. Shortly thereafter he was promoted to Weekend Anchor. In 1994 he became co-anchor of Connecticut's top rated early morning newscast "Good Morning Connecticut at 5am" and "Good Morning Connecticut at 6am". Kountz also co-anchored News Channel 8 at noon. In 1998, Kountz left Connecticut to become a main anchor at WJXX in Jacksonville, Florida.

"I'm so thrilled to be back", says Keith. "Connecticut is like home to me. I love the area, my family loves the area and being back is a dream come true". He goes on to say "the people of News Channel 8 are like family. I've known Ann, Mel and Geoff for over a decade. They're more than coworkers, they're friends and they make the work environment that much better".

While at WTNH, Kountz received acclaim for his news series called "Who We Are", which focused on individuals, organizations and issues important to minorities throughout the state. He also hosted "Wednesday's Child", a weekly series that featured children in need of adoption. As a part of the greater New Haven community for more than 13 years, Keith has worked closely with a variety of charities. Some of these include the Juvenile Diabetes Foundation, Big Brothers / Big Sisters and the Boys and Girls Club.

Before working in New Haven, Keith served in a similar capacity at WIXT-TV in Syracuse, New York. He has also worked at WSAV-TV in Savannah, Georgia and WPDE-TV in Florence, South Carolina. Keith has been the recipient of more than 40 civic and professional awards, including the Greater New Haven NAACP Media Award (2000), the Greater New Haven 40 Under 40 Award (1997) and LIN Television's "Circle of Excellence" award.

An avid golfer, Keith and his wife Dawn are the parents of two daughters.

- In 1998, Stephen was asked to lead a bold effort to create and develop the first statewide assessment program for career and technical education. All states by federal statute were required to begin similar assessment programs, but Connecticut was one of only five states that created statewide assessment programs that still exist. Currently the Connecticut Statewide CTE Assessment Program is regarded as the most comprehensive system of its type in the nation. It is the only state CTE assessment program in the country that includes the contextual application of academic competencies; fully administered on line for all Connecticut secondary schools testing approximately 9, 500 students annually.
- ♦ In 2006 following many years of research, he designed the Developing Tomorrow's Professionals (DTP) program, a comprehensive approach to education application and achievement for Black and Latino young men. The DTP, a ground breaking program designed to prepare young men for a 4-year college education leading to degree achievement and the selection of a professional pathway includes the development of measured academic skill sets (i.e., critical thinking, speaking and writing), continuous wrap around mentoring, assessment and follow-up. In the 7 years the DTP has been in existence, young men have graduated their respective high schools and matriculated to such universities as Howard, Yale, Brown, Cornell, Air Force Academy, University of Connecticut, our state universities and many others.
- In 2008, Dr. Hoag was recognized as the recipient of the national Olivio Award given to one person each year for leadership and creativity in student assessment by the National Occupational Competency Testing Institute.
- Dr. Hoag has been a high school & college football coach for over 30 years and in 1997 was honored as Assistant Coach of the Year by the Connecticut High School Coaches Association.
- Stephen was honored by the Wallingford Education Foundation as a Distinguished Alumni Award recipient in 2008.
- AUTHOR—Dr. Hoag's book, A SON'S HANDBOOK. "Bringing Up Mother with Alzheimer's / Dementia", published by Guidepost is scheduled for release in December 2013.
- Stephen is blessed by his wife Gina and twin daughters, Kathleen and Maureen Stephen gives all credit for these blessings to his walk with God.

- ◆ A graduate of Lyman Hall High School, Stephen is one of the most creative and inspirational educators in Connecticut
- ♦ While an undergraduate at Central Connecticut State University, Stephen was elected National President of DECA in 1973, earning Presidential recognition for his work across the country on the national Bicentennial program.
- Beginning his career in education in 1974 while serving as a marketing teacher at Norristown Area High School in Pennsylvania, he led his 1976 marketing program / DECA Chapter to the National Championship that included twelve #1 ranked student marketing projects and performances in Pennsylvania and three #1 national student champions. In 1977 he wrote and produced the second of two student performed musicals. "Decades of Diamonds" that won national acclaim from educators and performing artists with a show schedule that included appearances in nine different states. In 1977 Stephen was honored as the Greater Philadelphia Teacher of the Year.
- Recruited to the Connecticut State Department of Education in 1977 to create a statewide student organization, the Vocational Industrial Clubs of America (currently known as SkillsUSA). Within ten years VICA became the largest career and technical education student organization in Connecticut, creating occupational skill centered technical committees in 14 professional trade areas. Membership included over 120 Connecticut companies, labor unions and professional organizations. He served as State VICA Director for 19 years.
- ♦ In addition to his duties with VICA, in 1991 he assumed the same state leadership post for the student organization of DECA (marketing education students). In 1994 Future Business Leaders of America (FBLA) was added to his state department of education assignments and Technology Student Association (TSA) in 1996. All these organizations were administered concurrently statewide by Dr. Hoag until 1997.

Senator Toni Nathaniel Harp

Mayor Elect: City of New Haven, Connecticut



Senator Toni N. Harp is serving her eleventh consecutive term representing the 10th Senatorial District and its residents. Her district includes western New Haven and northern West Haven. She was reappointed to lead the budget-writing Appropriations Committee for a sixth consecutive term; she is also the vice-chair of the legislature's Aging Committee. Senator Harp also serves on the influential Executive and Legislative Nominations Committee and the Legislative Management Committee.

On November 5, 2013, Senator Harp was elected to the high office of Mayor of the City of New Haven, Connecticut. In this position she will be the first woman so elected and the second African American to hold this high position.

This year, Senator Harp is particularly pleased by full implementation of her Raise the Age juvenile justice initiative, which, "transformed a previously wasteful, punitive, ineffective and often abusive juvenile justice system into a national model—at no additional cost to the taxpayers," according to Washington's Justice Policy Institute.

Throughout her tenure, Senator Harp has prioritized many initiatives important to her constituents, including managed care reform, providing insurance for uninsured children, raising the minimum wage, advocating economic development for cities, encouraging an early detection system for child abuse, prohibiting drive-through deliveries, supporting truancy court and ensuring the safety of children in child care. Senator Harp has worked hard to bring state resources to local small businesses and to open the legislative process to constituents.

Her standing has been recognized by numerous groups, associations and organizations: the American Lung Association of Connecticut presented her with a Breath of Life Award; it had previously named her Legislator of the Year for her leadership in the areas of public health and lung health. End Hunger Connecticut! Commended her for efforts to redistribute food and get it onto the plates of those who struggle to afford it, and she also received a Legislative Award from the Connecticut Psychological Association for her leading role in maintaining access to mental/behavioral health services for state residents.

Senator Harp was a recipient of the 2007 Dr. Nathan Davis Award for Outstanding Government Service in the category Outstanding State Senator. This award was established by the American Medical Association and is one of the most prestigious forms of recognition for outstanding public service in the advancement of public health.

She received an annual Legislative Award from Connecticut Sexual Assault Crisis Services, Inc. for her 'unfailing' support and assistance on behalf of legislation to help sexual assault victims, survivors and their families. She has also been active in efforts to reform Connecticut's corrections system and has spoken many times before corrections and probation officers.

Senator Toni Nathaniel Harp

In 2000, Senator Harp received the Distinguished Citizen Award from the Connecticut Psychiatrists Society. She has also been selected by the New Haven County Silver Shields to receive the Dedicated Service Award. The Connecticut Chapter of the American Academy of Pediatrics presenter her with its annual award. She has been named Woman of the Year Award from the African-American Affairs Commission. She was also named 2000 Family Legislator of the Year by the Connecticut Council of Family Service Agencies for her extraordinary efforts to strengthen families in our state. She received the Clarence Daniel Advocacy Award from the Connecticut AIDS Residents Coalition. Senator Harp received the Women's Advocacy Award from the Connecticut Women's Consortium and she was honored by Children in Placement — CT/CASA (CIP) for her contribution to a better life for Connecticut's abused and neglected children.

In 1999, the Connecticut Chapter of the NAACP selected Senator Harp to receive its Clarence Mitchell Political Action Award. She was cited for her outstanding leadership in a number of issues, including manager care reform, the increase in the minimum wage, economic development for cities and making insurance coverage available to uninsured children, among others. Also in 1999, Senator Harp received the Phoebe Bennett Award from the Connecticut Association of Mental Health Clinics for Children.

In 1998, she was selected by the Council of State Governments for its prestigious Toll Fellowship Program. In 1997, Senator Harp was named Legislator of the Year by the Connecticut Psychological Association for her work on managed care legislation. In 1996, many groups honored her, including her peers in the Connecticut State Senate in a bi-annual recognition ceremony at the Old State House when she was named "the Conscience of the Senate." She was also honored by the U.S. Congress as the 1996 Woman of the Year from Connecticut's Third Congressional District for "her achievements and contributions in public service and the advancement of women's issues."

In 1995, she was awarded citations by the National Association of Social Workers, the Connecticut Association for Human Services, the New Haven Chapter of the National Association of Negro Business and Professional Women's Clubs, Incorporated. She was also honored as one of New Haven Business' 20 Noteworthy Women. Senator Harp received her Bachelor of Arts in English from Roosevelt University in Chicago, Illinois and a Master of Environmental Design from Yale University in New Haven, Connecticut.

She is a member of Links, Inc., the New Haven Alumnae Chapter of Delta Sigma Theta, Incorporated, a public service sorority and the Coalition of 100 Black Women.

Senator Harp has lived in New Haven for more than 25 years and is currently employed as the Homeless Service Director at the Hill Health Center. She is the proud mother of three children—Djana, Jamil and Matthew.
